**1. Accounting policies**

**Statement of compliance**

The financial statements have been prepared in accordance with International Financial Reporting Standards.

For the Kenyan Companies Act reporting purposes in these financial statements, the balance sheet is represented by/ equivalent to the statement of financial position and the profit and loss account is presented in the statement of income.

The principal accounting policies adopted in the preparation of these financial statements are set out below:

**a) Basis of preparation**

The preparation of financial statements in conformity with International Financial Reporting Standards requires the use of estimates and assumptions. It also requires management to exercise its judgment in the process of applying the accounting policies adopted by the company. Although such estimates and assumptions are based on the directors' best knowledge of the information available, actual results may differ from those estimates .

**b) Revenue recognition**

Sales represent the fair value of consideration received or receivable for the service offered, and are stated net of Value Added Tax, rebates and trade discounts. Cash discounts are included as part of finance costs.

Sale of goods are recognized in the period in which the company delivers products to the customer, the customer has accepted the products and the collectability of the related receivables are reasonable assured.

Interest income is accounted on a time proportion basis using the effective interest method.

**c) Property and equipment**

All categories of property and equipment are initially recognized at historical cost. All other items of property and equipment are stated at historical cost less accumulated depreciation and accumulated impairment losses.

Subsequent costs are included in the asset's carrying value only when it is probable that future economic benefits associated with the item will flow to the company and the cost of the item can be measured reliably. Repairs and maintenance is charged to the profit and loss account in the year to which it relates.

Depreciation is charged so as to allocate the cost of assets less their residual values over their estimated useful life, using the straight line method at the following annual rates:

**c) Property and equipment (continued)**

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

Property and equipment are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use.

Gains and losses on disposal of property, plant and equipment are determined by reference to their carrying amount and are taken into account in determining operating profit.

**d) Provision for liabilities and charges**

Provisions are recognised when the company has a present legal or constructive obligation as a result of past events and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made.

**e) Retirement benefit obligations**

The company and the employees contribute to the National Social Security Fund, a national defined contribution scheme. Contributions are determined by local statute and the company's contributions are charged to the profit and loss account in the year to which they relate.

**f) Employee entitlements**

**g) Borrowing costs**

Borrowing costs are recognised as an expense in the year in which they are incurred.

**h) Taxation**

Tax expense in the profit and loss account is the aggregate of the current income tax and deferred income tax.

**Current tax**

Current tax is provided on the basis of results for the year adjusted in accordance with the

**i) Financial instruments**

The company classifies its investments into the following categories:

i) **Held-to-maturity investments** which are non-derivative financial assets with fixed or determinable payments and fixed maturity that an entity has a positive intention to hold to maturity.

iii) **Available-for-sale financial assets** which are assets held for an indefinite period of time, but may be sold in response to needs for liquidity or changes in interest rates.

**i) Financial instruments (continued)**

All financial assets are classified as non-current except those with maturities of less than 12 months from the balance sheet date, those which the directors have the express intention of holding for less than 12 months from the balance sheet date or those that are required to be sold to raise operating capital, in which case they are classified as current assets.

All financial assets are recognized initially using the trade date accounting which is the date the company commits itself to the purchase or sale and recorded at the fair value of the consideration given plus the transaction costs. Subsequently, held-to-maturity investments and loans and receivables are carried at amortized cost using the effective interest method.

The directors classify financial assets as follows:

\* Receivables are classified as 'loans and receivables' and are carried at amortized cost using the effective interest method.

\* Term, current and call deposits with banking institutions are classified as 'held-to-maturity investments' and are carried at amortized cost using the effective interest method.

**Financial liabilities**

All financial liabilities including borrowings are recognized initially at fair value plus the transaction costs and subsequently carried at amortized cost using the effective interest

**j) Receivables**

Receivables are recognized initially at fair value and are subsequently measured at amortized cost using the effective interest method.

A provision for impairment is recognized in the profit and loss account in the year when recovery of the amount due as per the original terms is considered doubtful. The provision is based on the difference between the carrying amount and the present value of the expected cash flows, discounted at the effective interest rate.

Receivables not collectable are written off against the related provisions. Subsequent recoveries of amounts previously written off are credited to the profit and loss account in the

**k) Cash and cash equivalents**

Cash and cash equivalents include cash in hand, term and call deposits with banking institutions and other short-term highly liquid investments in money market instruments with maturities of three months or less from the date of acquisition net of bank overdrafts.
